PLEASE NOTE THE FOLLOWING TTWS CONTRACT AGREEMENT:

TK registrants will be required to submit one month's tuition by March 5th. This tuition will be applied in arrears for May's tuition and is non-refundable.

TTWS will mail class confirmation and billing statements for tuition in February, 2010. September's tuition is due by May 1, 2010. Each month thereafter (beginning June 1) one month's tuition is due by the first of each month. Payments will be past due if not received by TTWS after the fifth of the month. Following this payment plan, last tuition payment for the year will be made in January 2011 (except TK). A late fee in the amount of \$25.00 will be assessed for any payment not received after the fifth of the month. Registration fees and tuition are **NON-REFUNDABLE**.

When a child is withdrawn after May 1st, tuition for the remainder of the school year becomes immediately due and payable. This tuition obligation will be forgiven in the following cases:

- 1) If the family moves out of the Charlotte area
- 2) When the vacancy is filled by another child from our wait list.

I, on behalf of myself, my spouse or any other legal guardian of my child, hereby release and hold (i) Myers Park Baptist Church, including the TTWS (collectively, "MPBC"), and (ii) MPBC's members, agents, employees and volunteers (collectively, "Associates") harmless from all claims, damages, losses or liabilities of any nature (including for injuries, sickness or death), which are not the direct result of gross negligence of the TTWS or its Associates. I agree to indemnify the TTWS and its Associates against any claims, damages, losses or liabilities incurred by TTWS or its Associates as a result of actions taken by me, my spouse, any other legal guardian of my child and my child related to the TTWS.

Toddlers attending two days per week (M/W or T/TH): \$225/month

Toddlers attending three days per week (M/W/F): \$265/month*

Twos attending two days per week (T/TH): \$225/month

Twos attending three days per week (M/W/F or M/W/TH): \$265/month

Threes attending three days per week (M/W/F): \$265/month

Threes attending four days per week (M-TH): \$285/month

Fours attending four days per week (M-TH): \$300/month

Fours attending five days per week: \$330/month

Transitional Kindergarten: \$360/month

*To be eligible for M/W/F Toddlers, toddlers must turn two between September 1st and December 31st

One-time Yearly Activity Fee of \$25 for Toddlers and Twos and \$50 per child for 3's, 4's and TK will be due with first month's tuition.
